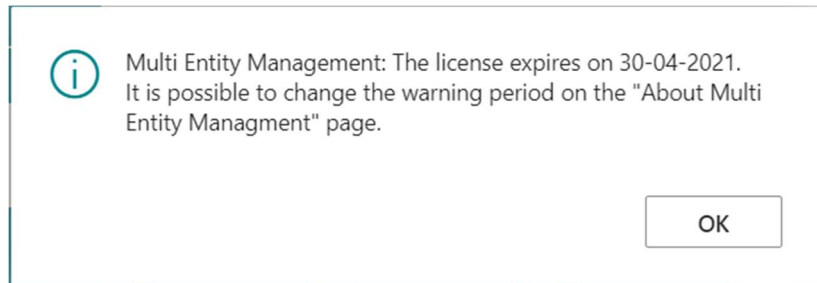

1.2 Trial license.

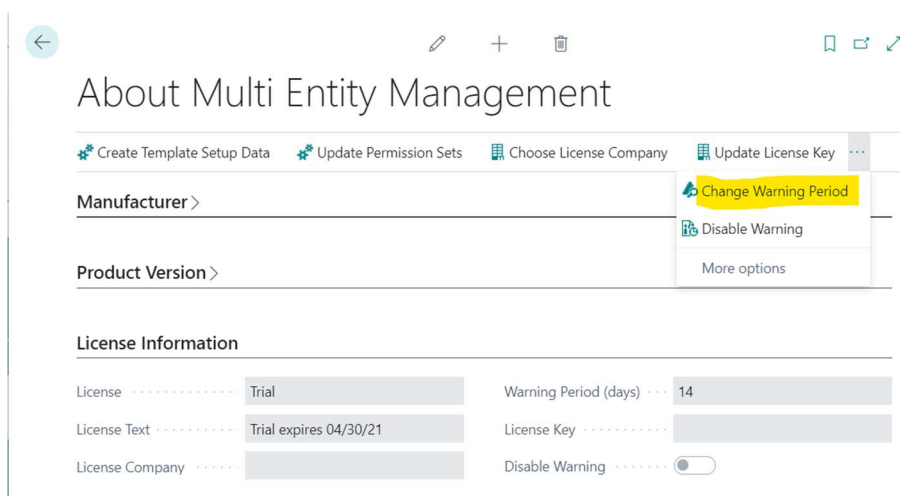
When installing Multi Entity Management, a Trial Period running until the end of the next month will be granted. In this Period the Multi Entity Management solution, will be is fully functional with no restriction. 14 days before the end of the Trial Period, a Warning message will appear.



1.2.1 Change Warning Period

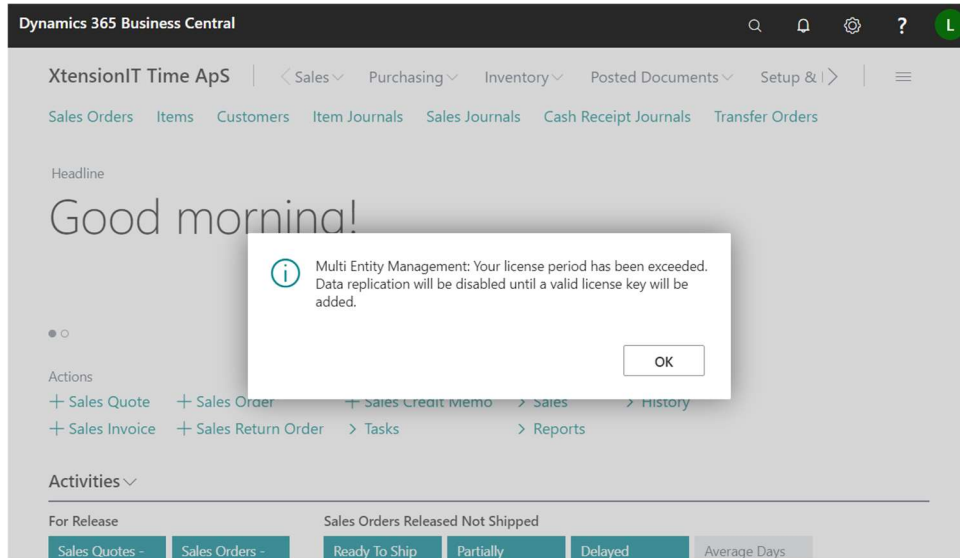
It is possible to change the Warning Period, so the Warning Message do not appear every day.

In the “About Multi Entity Management” page, choose the “Change Warning Period” and assign the number of warning days.

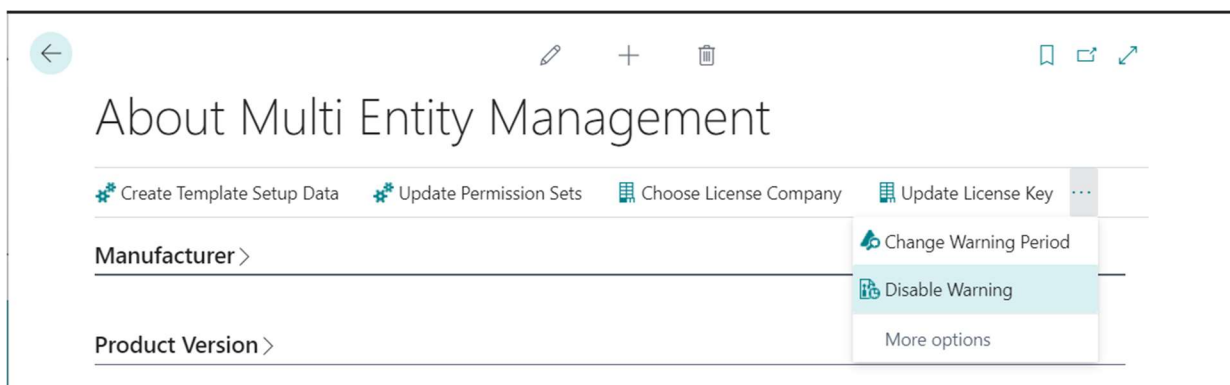


1.2.2 Expire Date, How to Disable Warning

When the Trial Date, Lease Period or Maintenance Date Expires, there will be a message, to inform about disabling of the “Data replication.” Functionality.




This message can be disabled at the “About Multi Entity Management” page, choose the “Disable Warning” and assign the number of warning days.



1.3 Update license

To enable a full functional license, you must require a license key from your NAV/BC Partner or directly at XtensionIT (info@xtensionit.com).

To get the license you must provide the “VAT No.” registered to the company that hold the license in the database.


1.3.1 Business Central Country versions without VAT Reg. No.

Note: This section can be skipped if there already is assigned a VAT Number to the License Company

When using Country versions Microsoft Dynamics 365 Business Central, without the “VAT Registration No.” the License Key will be based on the Microsoft Account for the license.

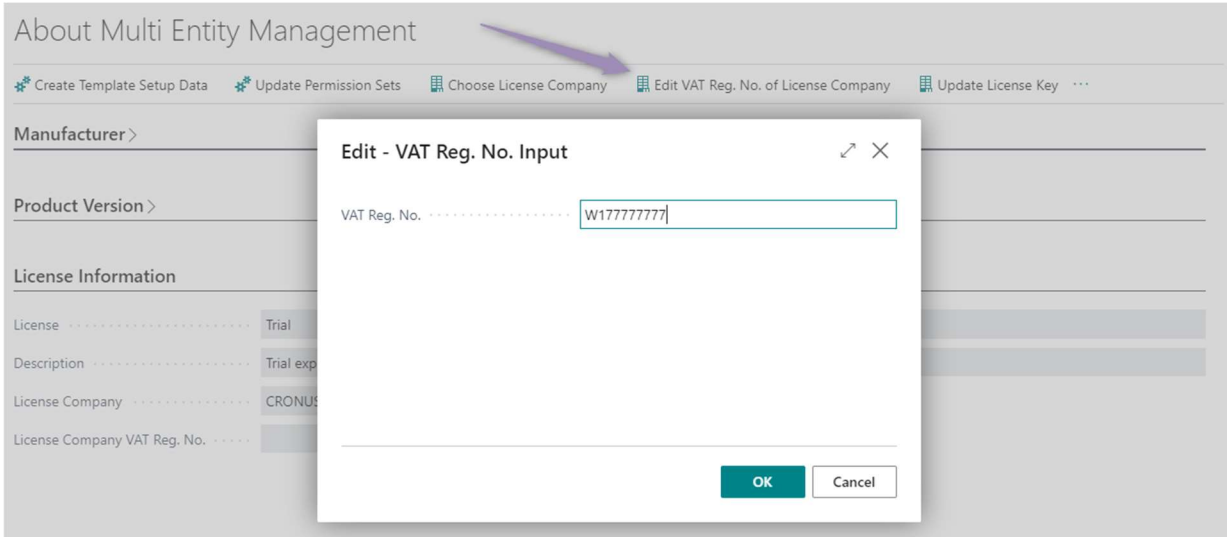
First choose the Company to hold the License, usually the Master Company.

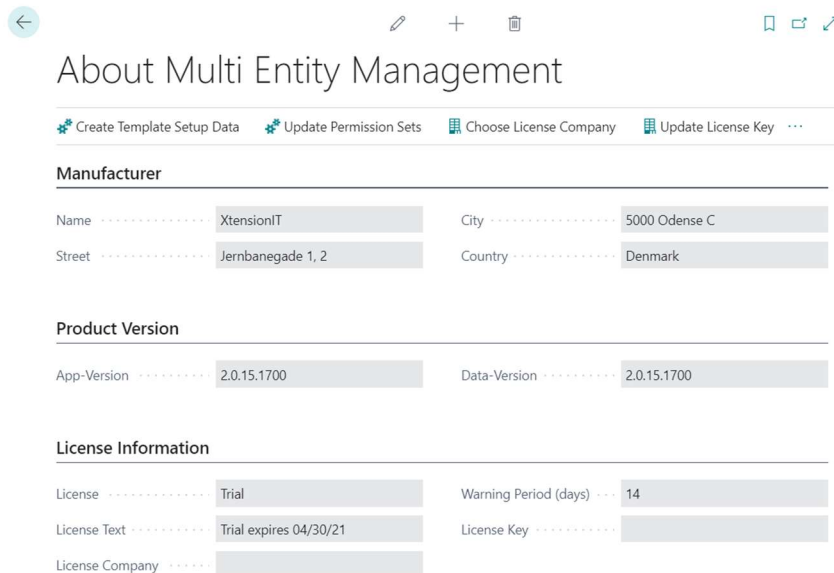

1.3.2 Update Process.

Use the following procedure to update the XtensionIT license Key.



- Activate "Choose License Company".

The Company selected, must have the same "VAT No." registered in the Company Information, as used to generate the MEM license.

- Activate “Update License Key”
- Choose between “Starter Pack”, “Extended Pack” or “Unlimited Pack”.
- Insert the License Key provided from XtensionIT.

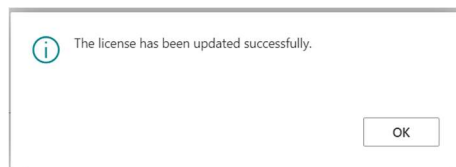

- The “Warning Period (days)” show how many days before Expiration of the Lease/Maintenance period, a warning will be show for the users. It is possible to change the number of warning days in “Warning Period (days)” with the action “Change Warning Period”.

1.4 Expiration Date

When the Expiration Date is exceeded, the replication functionality is disabled. Data is not deleted and the replication can be resumed with an updated license.

There is an expiration Date to Trial, Lease and Maintenance.


1.5 Replication Companies.

Multi Entity Management is license by the number of companies that uses the replication functionality.

- The Starter Pack license allows up to 20 companies to replicate Master data in the same database.
- The Extended Pack license allows up to 100 companies to replicate Master data in the same database.
- The Unlimited Pack license allows unlimited number of companies to replicate Master data in the same database.

It is only the Template Companies, that are counted as a Multi Entity Management company. A company is registered in the license, when one of the following features is activated.

- Template Company
- Dependent Company
- Reporting Company
- Consolidate Company


